### Company Pays for Part B Cover

Company provides and pays for Part B cover for all their staff, for the duration of their employment. The Insurance Premium Tax is 12%, included in the premiums listed

### Staff Pay for Part C Cover

Staff member has the option to purchase Part C cover, which remains theirs for the duration of the policy. The Insurance Premium Tax is 12%, included in the premiums listed

*If you choose this option, when you add your staff's details to the Online register, all premiums will be automatically calculated for Parts A & B, an e-mail will be sent to your staff member to give them details and the option to purchase Part C and informs you so you can collect the premium from them.*

*MPI Brokers will invoice you at the end of the month and then on a monthly basis if changes are made during the season.*
