How does this work?

Cover is open to all companies who employ staff working abroad.

MPI offer three levels of cover:-

PART A

Is where the premium is paid by the company to insure all staff for, Emergency Medical Expenses, including Mountain Rescue and Repatriation & Personal Liability.

Part A must be purchased for all your staff, you may not pick and choose.

PART B

Provides cover for other risks, such as Personal Belongings, Lift Pass, travel costs following Bereavement at home, Legal Expenses and so on.

The premiums for this level are determined by the method you wish to adopt for providing this part to your staff. You can provide this cover for your staff, or your staff can purchase themselves. There are three options to provide Part B cover – Inclusive, Opt Out or Optional, please go to our website www.mpibrokers.com to see these options in detail, plus the various premiums.

PART C

Covers ‘all risks’ of physical loss or damage to, electrical items, such as Laptops, iPods, Cameras, Games Consoles, iPads and the like.

Your company can purchase this for your staff, if you don't then it must be offered to all staff to purchase themselves. Please note premiums are higher for Part C if Part B has not also been chosen.
